MHSTCI's interest relates to conserving Ontario's cultural heritage resources include archaeological resources, built heritage resources, and cultural heritage landscapes. Proponent is required to determine potential impact on known and potential cultural heritage resources. It was noted that the project may impact archaeological resources and should be screened using the MHSTCI Criteria for Evaluating Archaeological Potential to determine if an archaeological assessment is needed; then if the area exhibits archaeological potential, then an Archaeological Assessment (AA) should be undertaken by an archaeologist licensed under the Ontario Heritage Act (OHA), and submit the report to MHSTCI for review. MHSTCI recommends doing a Cultural Heritage Report, Step 1 undertaken early in planning process. Steps 2 and 3 can be undertaken once the preferred alternatives have been selected. Steps described as (1) description of existing baseline cultural heritage conditions, (2) identify preliminary potential project-specific impacts, (3) Recommended measures to avoid or mitigate potential negative impacts. MHSTCI recommends engagement with Indigenous communities for any knowledge that can contribute to the identification of cultural heritage resources. MHSTCI requested that the studies and recommendations be incorporated into the ESR, and advise MHSTCI of any reports completed and provide to MHSTCI prior to NOCC.
